JOINT MOTION TO CONTINUE FINAL FAIRNESS HEARING DATE & CLARIFY CERTAIN DEADLINES

Defendants TransUnion Rental Screening Solutions, Inc. ("TURSS") and Trans Union LLC ("Trans Union") (collectively, "Defendants") and Plaintiffs (collectively, the "Parties") respectfully move the Court to continue the Final Fairness Hearing on the Parties' Class Action Settlement by two weeks and to clarify certain deadlines. In support, the Parties state as follows:

- 1. On January 6, 2023, the Court entered the Order Preliminarily Approving Class Action Settlement and set the Final Fairness Hearing for August 24, 2023, at 9:00 AM.
- 2. Lead attorney for Class Counsel has a previously scheduled conflict with that date, which involves out of state travel that continues throughout the following week as well.

- 3. Therefore, the Parties respectfully request that the Court continue the Final Fairness Hearing by two weeks, to September 7, 2023, or a date that is otherwise convenient to the Court that is after Labor Day (September 4, 2023).
- 4. The Parties make this request now so that the notices issued to the Class Members include the continued date of the Hearing, should the Court grant the Parties' request.
- 5. Regarding the Class List, which Plaintiff's counsel is currently due to provide to Defendants' counsel on February 24, Plaintiffs are working diligently through the review of the Initial Class Data but require an additional week to finalize the List, up to and including March 3, 2023.
- 6. Additionally, it was the Parties' intention that the "Rule 23(b)(3) Claims Deadline" track the Rule 23(b)(3) Opt Out and Objection Deadlines, but the Settlement calculates those two dates slightly differently. The Preliminary Approval Order set the Rule 23(b)(3) Opt Out and Objection Deadlines as postmarked sixty (60) days from the mailing of Notice. To harmonize the two dates, the Parties request that the Court order the Rule 23(b)(3) Claims Deadline to be the same, postmarked or submitted within sixty (60) days from the mailing of Notice.
- 7. Further, it was the Parties' intention that the deadline for the Settlement Website to "go live" would track the deadline for the Rule 23(b)(3) Notices to be

distributed, but, again the Settlement calculates those two dates slightly differently. The Preliminary Approval Order set the deadline for Rule 23(b)(3) Notices to be distributed as thirty (30) days from the Settlement Administrator's receipt of the Class List. To harmonize those dates, the Parties request that the Court order the Settlement Website "go live" on that same date.

A proposed order is attached for the Court's consideration.
